- 7. Rick will send a treasurer's report to the Board. One is not available for this meeting. Randy does not yet have online access to the account.
- 8. Rick is looking at seeking "runner friendly" status for Williamsburg. The club will pursue this. Also, the Governor's Land 5K will be the Virginia Road Runners Club of America 5k championship.
- 9. Rick has prepared a list of current members but is still working on membership expiration dates.
- 10. Minutes from the last meeting were approved. Stan reported that as of yesterday we have 90 followers on Twitter, 430 on Facebook, 214 on the announcement list and 155 on the discussion list. He will also begin putting copies of the minutes on the website.
